

RETOUR of the GENERAL SERVICE of DOUGAL CAMPBELL OF CLENMACRIE as nearest and lawful heir of the line and provision to the deceased COLIN CAMPBELL, sheriff-depute of Lorn, his great-grandfather on the father's side. Mention is made of a Disposition by the deceased PATRICK CAMPBELL OF BARCALDINE, there in designed of Dalmerglan, to the said COLIN CAMPBELL, commissary of Lorn, and ISOBEL STEWART, his spouse, and their heirs, dated 19th and 28th June 1635. Deposition is made that the said DUGALD CAMPBELL is eldest lawful son of the deceased ALEXANDER CAMPBELL OF CLENMACRIE, who was the eldest lawful son of the deceased DUGALD CAMPBELL OF CLENMARIE, who was eldest lawful son of the deceased COLIN CAMPBELL, sherrif-depute of Lorn, procreated between him and Isobel Stewart, his spouse. DUGALD CAMPBELL OF CLENMACRY as nearest agnate and kinsman on his father's side to DUGALD CAMPBELL OF EDERLINE, his grandfather's brother's son, compared with a brief of furoiosity seeking to be served tutor ad litem to him, and is appointed as such. On the jury were NEIL CAMPBELL of DUNTROON, ARCHIBALD CAMPBELL OF INVERLIVER, ARCHIBALD CAMPBELL OF KNOCKBUY, ANGUS CAMPBELL OF ASKNISH, NEIL CAMPBELL OF AUCHINARD, RONALD CAMPBELL OF SCAMADELL, DONALD CAMPBELL, bailie of Ross in Mull, COLIN CAMPBELL, another of the baillies there, ROBERT CAMPBELL OF KENTRAE, JOHN CAMPBELL, younger thereof, JAMES CAMPBELL OF AUHINTRA, JOHN CAMPBELL of GLENFEACHAN, ARCHIBALD CAMPBELL, one of the baillies of Inveraray, and ARCHIBALD CAMPBELL, tacksman of Knockvolagan. Sasine of the same land (under reversion for 4,000 merks) in favour of Dugald Campbell, brother german of the above Alexander C., on a charter confirmation by Sir Hugh. Rest the same, except that the attorney's father is styled "late John Campbell of Kirkton of Muchairn.

Sasine of the 10d. land of Clenamacrie in the barony of Kilmaronag in Argyll, given by John Campbell in Kirkton, as a baillie, to Donald Campbell (son of late John C. in Kirkton), as attorney for Alexander Campbell, as son and heir male of late Colin C. (who was brother german of late Archd. C., Captain of Dunstaffnage), on a precept of clare constate by Hugh Campbell of Calder, signed at Brodie, 13 Oct. 1664, before James Brodie, younger of Brodie, Donald Campbell, brother german of the said Sir Hugh, and John Brodie, servitor to Alexr. Brodie of that ilk. Witnesses to sasine; Duncan M'Cullow in Clenamacrie, Duncan M'Indeor. And Gilbert M'Muncader [sic" M'Noucater?] there, and Alexr. Campbell, servitor of grantee.
