OPEN BUSINESS

12784. Welcome

The Principal welcomed all members to the first meeting of Senate in AY 2023-24. The Principal in particular extended a warm welcome to the new Student Executive and to the 14 new members of Senate.

12785. Minutes of the meeting of 31st May 2023 (Paper S23-24-01)

The minutes of the meeting of 31st May 2023 were approved as an accurate record.

12786. Matters Arising

There were no matters arising.

12787. Report from Senate Business Committee (Paper S23-24-02)

The Vice Principal invited Senate to note the report of the Senate Business Committee which had met on 23rd August. The Committee had scrutinised the following:

1. The note of the Collaborative Provision Agreement (CPA) Subgroup, noting that since the last meeting of Senate on 31st May 2023 the CPA Subgroup had processed five agreements, three of which were approved out of cycle and are reported in the Principal's report for Senate to homologate, Paper S23-24-03.
2. The report from the joint meeting of the Collaborative Provision Agreement Subgroup and a subgroup of Quality Assurance Committee which took place on 27th June 2023.
3. The Committee's Terms of Reference for AY 2023-24. These were reviewed and approved.
4. The Committee agreed the business agenda of Senate's meeting of 6th September 2023. The Strath Union President was asked to provide a verbal update to Senate on recent Strath Union business. It was agreed that Senate would receive a presentation on NSS Results 2022-23 from the Deputy Associate Principal Learning and Teaching, followed by a verbal report from each of the Deans on the performance of their respective Faculties in the survey. The Deputy Associate Principal, Academic Quality and Student Experience, was asked to present an overview of the [results of the QAA's Quality Enhancement and Standards Review](#). It was agreed that Senators would receive a presentation on Generative AI capturing current sector views and how assessment practices can be adapted to work with AI. Finally, Senate would also receive a recruitment update from the Director of Strategic Planning and a financial update from the Acting Chief Financial Officer.
5. All reports submitted for the Senate meeting had been reviewed and were recommended for approval by the Senate Business Committee.
6. Requests for Senate's attention and approval were highlighted; with a recommendation that Senate give its formal approval to reports as noted below (Minute ref 12800-12812).

12786. Renewal of the Principal's Appointment

The Vice Principal, in the absence of the Principal, consulted with Senate on the re-appointment of the

Principal for a further period of just over two years. Senate was asked to consider the Re-appointment Panel's recommendation of a further renewal to the Principal's contract from 1st August 2024 to 30th September 2026. Senators welcomed this proposal and unanimously endorsed the extension to the Principal's contract, with a number of Senators offering positive commentary on this proposal.

12787. Student Voice

Eva Curran, Strath Union's President, presented the Student Union update, noting that the development of the strategic framework between the Union and the University was progressing well and is due to be signed off in October. She brought to Senators' attention the difficulties that students were having securing Discretionary and Childcare Funding due to the delays from SAAS in confirming the grant amounts. This is a national issue and the Principal and University Secretary gave support to raising the concern to the Scottish Government through their networks. Finally, the President noted that the Union has organised a wide range of events for Freshers' and that all of the officers were looking forward to welcoming new students onto campus.

12788. NSS Results 2022-23

The Deputy Associate Principal for Learning and Teaching provided Senate with an update on the annual NSS results. It was noted that there had been significant changes to the NSS survey in the last year which affected the types of comparisons that could be made to previous years' data, as the methodology has been fundamentally changed. The University had improved its score in overall satisfaction, placing it 5th in Scotland in this measure and significantly above the UK benchmark. The two areas that are the focus of development are around Assessment & Feedback and Student Voice. Although there is improvement to be made in these areas it was noted that the University has gone from 99th to 6th in the UK in the Student Voice set of questions which demonstrates the impact of the work being undertaken in this area. The Executive Deans for each Faculty gave an overview of the data from each of their respective areas. They noted that although it was a very difficult landscape for final year students, with the majority being on campus for the first time and the impact of the cost of living crisis and industrial action, the results were generally positive and the University retained its top quartile position for the 5th consecutive year.

12789. Outcome of Quality Enhancement and Standards Review

The Deputy Associate Principal for Academic Quality and Student Experience provided Senate with an overview of the outcome of the QAA's Quality Enhancement and Standards Review. It was noted that the outcome of this review had been very positive with the QAA being confident that the institution is making effective progress in continuing to monitor, review and enhance its higher education provision to enable effective arrangements to be in place for managing academic standards and the quality of the student learning experience. Four key areas of good practice were identified, namely: strategic approach to good standards, use of data and evidence to inform self-evaluation and decision making, student partnership working, and digital education. Two recommendations were made around forward timetable development for thematic reviews, and ensuring that the Guidance for Postgraduate Research Students Who Support Teaching and Teaching-related Activities is fully and consistently implemented. 12790. Generative AI

The Vice-Dean Academic, HaSS and the Deputy Director of Education Enhancement presented to Senate on the impacts and opportunities presented by Generative Artificial Intelligence for learning, teaching, and assessment. The landscape around Gen AI was discussed, an overview of the work that has already been undertaken by the University was presented, and a proposed outline of next steps and key actions was provided. It was noted that this was a rapidly developing area with the potential for profound impact across the Higher Education sector.

12791. Recruitment and Financial Update

The Acting Chief Financial Officer presented an overview of the draft budget for 2023-24 and provided some context around the presented figures. An early loan repayment of £61.7M to the European Investment Bank was noted. The Director of Strategy and Planning presented a recruitment update to Senators, this focussed on the upcoming September 2023 intake.

12792. Principal's Update

Contrary to the published Senate agenda, at the Principal's request this update was provided after the substantive items.

The Principal provided a comprehensive report on news and items of interest since the last meeting, covering the following key topics:

Innovation

The focus of the Scottish Government's recent programme on innovation and entrepreneurship was highlighted. It is hoped that Strathclyde can be a key partner in the development of this work and a catalyst to support the intention of the First Minister to improve relationships between the Government and industry.

New areas of development for the University in the Middle East were emphasised, this included pharmacy, fintech and renewables, as well as plans to support the implementation of the innovation district model at other institutions.

Industrial Action

The end of the Marking and Assessment Boycott by UCU was announced. It was noted that Unite members are taking five days of industrial action in September, with UCU also taking five days of action later in the month. The Industrial Action Planning Group is meeting regularly to reduce the impact of the action on students as far as possible.

Strathclyde 2030

The Principal commented on the high levels of engagement that had been seen in the consultation of the 2030 Strategic Plan. The Plan will be presented to Court for final approval in the coming months.

Strathclyde's Historical Links with Transatlantic Slave Trade

A report will be published in the coming months examining the University's links with the Transatlantic Slave Trade. To recognise the impact of these links and the financial benefits historically bestowed to the University a full calendar of events and activities are planned for Black History Month. A new Racial Equity and Anti-Racism Steering Group (REARSG) has been established to ensure the ongoing commitment to equality, diversity, and inclusion across the institution.

Safe 360

It was noted that to support the University's commitment to the Safe 360 approach new modules were required for all new Undergraduate students on Gender Based Violence, and Equality, Diversity and Inclusion. Senators were reminded that all staff must undertake the mandatory Data Protection and Cyber Security training modules.

Athena Swan Silver

The Principal offered congratulations to Strathclyde Business School on the Athena Swan Silver award for the Faculty.

Daily Mail University Rankings

It was noted that the University has been ranked very highly in a new University ranking published by the Daily Mail, the formal announcement of which would be released at the weekend.
