### OPEN BUSINESS

#### **12641. Welcome**

The Principal welcomed all members to the last meeting in the 2021/22 Academic Year of Senate, taking place fully in-person on campus.

#### **12642. Minutes of the meeting of 23<sup>rd</sup> March 2022 (Paper S21-22-73)**

The minutes of the meeting of 23<sup>rd</sup> March 2022 were approved as an accurate record.

### **12643. Matters Arising**

### **12644. Report from Senate Business Committee (Paper S21-22-74)**

The Vice Principal invited Senate to note the report of the Senate Business Committee which had met on 19<sup>th</sup> May 2022. The Committee had scrutinised the following:

1. The report of the Collaborative Provision Agreement Subgroup. Senate Business Committee noted that, since the last meeting of Senate on 23 March 2022 the CPA Subgroup had processed seven agreements, four of which were new agreements and three were renewals to existing agreements. Of the renewals, one was a renewal where the academic terms and conditions had not changed. In line with the CPA Subgroup's Terms of Reference, a review of this renewal was undertaken by the Quality Enhancement and Assurance Team who provided the necessary confirmation to the CPA Subgroup that the appropriate academic due diligence had been undertaken.
2. Senators were asked to note that an effectiveness review of Senate will be undertaken over the summer months and will report to the September meeting of Senate.
3. Senate was also notified that in response to the growing number of collaboratively delivered programmes that the University enters into, work will be undertaken to update our governance processes to ensure that the appropriate level of oversight and scrutiny of programmes, programme regulations, fees, Data Sharing Agreements and collaborative agreements, is undertaken *before* Senate is asked for its approval.
4. Senate endorsed the QAA's [Academic Integrity Charter](#), detailed in the Education Strategy Committee Report to Senate (Paper S21-22-79). This will now be progressed with the QAA.
5. The Committee agreed the business agenda of Senate's meeting of 1<sup>st</sup> June 2022 and welcomed a presentation from the Deputy Associate Principal (Learning and Teaching) and the Vice Deans (Academic) on e-FIRST (education – Future Innovation and Reflection on Strathclyde Teaching). It was agreed that the emphasis of this item would be on transition arrangements for returning to campus in 2022/23, assuring Senators that preparation for on-campus teaching is well underway. The Student President was asked to provide a verbal update to Senate on recent StrathUnion business. Senate would receive a general update on the University's financial position from S Wallace, Chief Financial Officer. And finally, it was agreed that the Executive Dean of Engineering, Professor Stephen McArthur and the Director of Research and Knowledge Exchange Services, Claire Carroll would be invited to present the results of the Research Excellence Framework 2021 to Senate.
6. All reports submitted for the Senate meeting had been reviewed and, subject to minor refinements, approved by the Senate Business Committee.
7. Requests for Senate's attention and approval were highlighted; with a recommendation that Senate give its formal approval to reports as noted below (Minutes 12650-12665).

## **12645. Principal's Report and Update**

### **Senate Elections**

Nominations are now open to staff for election to Senate for 2022-23. Nominations are welcome from academic, research, teaching and knowledge exchange staff by the closing date of 14 June 2022. Colleagues can find all the information about the process in Inside Strathclyde.

The Principal thanked all those Senators demitting office this year for their valuable contributions to the work of Senate. In particular, those members of the Student Executive who will not return to their Executive roles in AY 2022-23 were thanked for their cooperative approach throughout AY 2021-22.

### **New Senior Colleagues**

The Principal also welcomed new colleagues, namely: Louise McKean as the University's first Compliance Officer; Wesley Rennison as the Director of Strategy and Planning; Charlotte Cannon as the new Director of Safety, Health and Wellbeing; Claire Carroll has been confirmed as the new Director of Research and Knowledge Exchange Services; Dr Churnjeet Mahn started as Deputy Associate Principal Research and Knowledge Exchange on 1st May and Professor Patricia Connolly is starting her position as Deputy Associate Principal Research and Knowledge Exchange on 1st June. In addition, the Principal informed Senate that Professor Debra Willison has been appointed as Deputy Associate Principal Online Learning and Teaching and will commence her new role on 1<sup>st</sup> August 2022, and Brian Green, currently Deputy Associate Principal Learning and Teaching, will commence his new role as Deputy Associate Principal Academic Quality and Student Experience, also on 1<sup>st</sup> August 2022.

It was noted that Dr Stuart Fancey will commence his position as the University Secretary on 6th June. The Principal thanked Gordon Scott for fulfilling his role as Acting University Secretary alongside his role as Chief People Officer. The Principal thanked Gordon on behalf of Senate.

### **REF 2021**

The Principal thanked everyone involved in the collective efforts around the successful REF 2021 submission. The University had a strong performance in the latest national assessment with almost 90% of our research rated 'world-leading' or 'internationally-excellent'.

### **External Recognition**

It was noted that Gillian Docherty, Chief Commercial Officer, has been appointed to the Scottish Government's National Strategy for Economic Delivery Board. Professor Mairi Spowage, Director of the Fraser of Allander Institute, has been appointed as a committee member of the new National Statistician's Committee for Advice on Standards for Economic Statistics which has been set up by the

UK Statistics Authority. And Professor Martin Dawson has been elected a Fellow of the Royal Society (FRS).

### **Awards**

StrathUnion colleagues were recognised at The Herald Higher Education Awards in the Widening Access category for their development of the role of an Access and Participation Coordinator, the first of its kind in a Student Union, with the role funded by the University as a strategic project proposal.

In April, the University was recognised as Scotland's best large employer at the S1 Jobs Recruitment Awards.

The University has retained the EU HR Excellence in Research Award for a further two years, following an internal review marking a decade as part of the programme.

As part of the development of Glasgow City Innovation District, the University is leading an ambitious project to deliver a 100% renewable climate-neutral and climate-resilient area within the District. The project, the Climate Neutral Innovation District, has been selected as a winner in this year's [International Sustainable Campus Network Excellence Awards](#) in the Partnerships for Progress category. The project was also named winner in the Collaboration in Net Zero category of the Industry Awards presented by CeeD (Centre for Engineering Education and Development), a network of business and academia which delivers peer-to-peer best practice sharing.

### **Strategic Court**

The Principal informed Senators that University Court met for a strategic session as we look beyond Vision 2025. The meeting was used to consider progress against the current strategic plan. Early discussions also took place around 'Strathclyde 2030' in the context of key institutional priorities and opportunities.

### **Accountability and Development Review**

The ADR process has commenced for this year. The Principal informed Senators that he and the Executive Team have completed their reviews.

### **Safe Return to Campus**

A recent communication from Gordon Scott, Chief People Officer advised colleagues that as we transition towards the next Academic Year, from the week commencing 20 June, all staff will be expected to have an on-campus presence each week. For full time staff it is expected that this will be a minimum of two to three days a week. It was noted that the University wants to retain the benefits that we have realised over the last two years through opportunities for agile and hybrid working. The agile working toolkit is key to how this approach is managed at a local level.

Senators were asked to encourage colleagues to familiarise themselves with the three new policies in relation to Gender Based Violence, Safeguarding and Child Safeguarding, available [here](#). The University actively encourages reporting of any incidence of inappropriate behaviour, so that it can be challenged and addressed, and appropriate support provided. This can be done through the [Report and Support](#) system.

## **Principal's Engagement Sessions**

The Principal has recently completed a round of Engagement Sessions which saw 1300 colleagues participating in the online events. 250 operational staff from Estates attended a recent face-to-face session in The Barony.

**12646. e-FIRST – update covering: review of AY 21-22, transition and support planning for AY 22-23, and preparation for on-campus teaching for AY 22-23**

The Deputy Associate Principal (Learning and Teaching) introduced a presentation to Senate on the readiness and transition to on-campus learning from the start of AY 2022/23. This introduction incorporated teaching room preparation, and the additional teaching and study space that is now available. It was noted that the full teaching estate would be available for AY 2022/23 as no buildings would be out of commission for upgrading works. Each of the Faculty's Vice Dean Academics (or nominee) was then asked to provide Senate with a brief overview on reflections from AY 2021/22, their Faculties' transition and support planning in place for AY 2022/23 and an outline of their preparations for on-campus teaching next academic year. It was noted that the e-FIRST group will continue to meet on a weekly basis to ensure continued good communication and early intervention if necessary.

Senate welcomed the e-FIRST overview and reassurance of the planning underway for return to campus and the extensive preparations for the forthcoming academic year.

**12647. Student Voice**

The StrathUnion President reported to Senate that over the last academic year, students have been well supported by StrathUnion and the University. The new Learning and Teaching Building has made a big difference in welcoming students back on to campus. The [Guidance and Procedure for Boards of Examiners in the Event of Disruption](#) has been particularly welcomed by StrathUnion and demonstrates the University's commitment to the continued support of students. Looking forward, the President noted the much welcome return to campus and noted students' enthusiasm for an on-campus experience. The new Student Executive team will commence their new roles on 1<sup>st</sup> July 2022 and are keen to build on the partnership approach that has worked well over the last academic year.

**12648. Financial Update**

The University's Chief Financial Officer presented Senate with an update on the current year forecast, noting that the Quarter 3 forecast has been prepared and will be presented to Court for approval on 16th June. A further improvement from the Q2 Forecast position was highlighted, with underlying surplus position in line with Budget. The 2022/23 budget is in the final stages of completion, with the final budget position to be presented to Court on 16<sup>th</sup> June. The current geo-political events have raised the risk profile for the coming academic year, specifically the impact of inflation. Managing that risk, while maintaining focus on the University's strategic vision, will be critical.

**12649. Research Excellence Framework 2021**

Professor Stephen McArthur, Executive Dean Engineering, presented the results of the University's REF 2021 submission. The excellent result achieved was the culmination of 7 years work. Academic and Professional Services colleagues were thanked for their collegiate approach to preparing and working towards this submission. The University's performance in the REF 2021 was solid and robust. It was noted that one of the main differences between our submission in 2014 and 2021 was the number of staff submitting to the REF (an increase of 40%), which demonstrates the quality of our staff and reflects well our strategy of recruiting and retaining outstanding academic staff, researchers and students.

The Principal thanked all colleagues involved in the REF 2021, and in particular colleagues within the Research and Knowledge Exchange Directorate.
